Biographical / Historical

The Coalition of Women's Art Organization was founded in 1977 with a goal of achieving equality for women in the art world. The CWAO sought to unite organizations throughout the United States and advocate at a national level and reduce or eliminate discrimination of women by grant awarding boards and comissions.

The records of the Coalition of Women's Art Organization measure 1.0 linear feet and date from circa 1961 to 1981. Scope and Contents:

Resumes and biographical sketches are found for Gertrude Barnstone, Janice Koenig Ross, and June Wayne, founding members of the Coalition of Women's Art Organization.

Administrative records include bylaws, fundraising and financial records, and draft form letters. The Coalition of Women's Art Organization conference in 1979 is documented with panelist resumes, three cassette tapes of lectures and meetings, and correspondence regarding the planning of lectures.

Correspondence consists of copies of letters from the Coalition of Women's Art Organization to politicians concerning public policy regarding the arts. Some scattered incoming correspondence is from institutions, government agencies, and members of the Coalition of Women's Art Organization.

Membership records include inquiries from potential members, membership lists, letters sent to new members, and records relating to the election of officers.

Subject files were compiled by the Coalition of Women's Art Organization and may include correspondence; printed material including announcements, congressional bills, and press releases; and writings and notes. The bulk of the subjects concern public policy for the arts on a national level.

Printed materials consist of brochures, newsletters, and press releases produced by the Coalition of Women's Art Organization and scattered other organizations.
