<b>Summary:</b>	The papers of artist Roy De Forest measure 11.2 linear feet and 111.86 gigabytes and date from 1916 to 2015, with the bulk of the collection dating from 1948 to 2007. The collection documents De Forest's painting career and involvement in the funk art movement through biographical material, correspondence, writings, professional records, printed material, photographic material, artwork, digital audio and video recordings, and artifacts.

## Administrative Information

### Acquisition Information

The Roy De Forest papers were donated in several installments from 1974 to 2019. Some materials were loaned for microfilming in 1974 and subsequently donated in 1977 and 1979 by Roy De Forest. Additional materials were donated in 2009, 2016 and 2019 by Gloria Marchant, Roy De Forest's widow.

### Related Materials

Also found in the Archives of American Art is an oral history interview with Roy De Forest conducted by Lynn Robert Matteson, April 7-June 30, 2004.

### Available Formats

The bulk of this collection was digitized in 2019 and is available on the Archives of American Art website. Materials which have not been digitized include an interview recording on videocassette, a 35mm filmstrip, estate papers. In some cases, exhibition catalogs and other publications have had their covers, title pages, and relevant pages digitized. Access copies of born-digital records are not online and are available at the Archives of American Art offices.

### Processing Information

The collection was minimally processed and a finding aid prepared by Rayna Andrews in 2018. A small addition, donated in 2019, was merged with the rest of the materials and the collection was fully processed, prepared for digitization, and described in a finding aid by Rihoko Ueno in 2019 with funding provided by Gloria Marchant. Born-digital materials were processed by Jessica Purkis in 2019.

## Biographical / Historical

Roy De Forest (1930-2007) was a painter, sculptor, and educator in Port Costa, California. A notable figure in the funk art movement, he coined the term "nut art" to describe art that embraced humor and created a fantasy world.

Born in North Platte, Nebraska, Roy De Forest grew up in Yakima, Washington where he attended Yakima Junior College and graduated in 1950. He went on to study at the California School of Fine Arts (now San Francisco Art Institute) and San Francisco State College (now San Francisco State University). He taught at Yakima Junior College from 1958 to 1960 after graduating from San Francisco State College, and later taught at the University of California, Davis from 1965 until his retirement as professor emeritus in 1992.

De Forest's first solo exhibition was in 1955 at the East & West Gallery in San Francisco. From then until his death in 2007, he exhibited frequently, especially at the Allan Frumkin Gallery in New York and the Hansen Fuller Gallery in San Francisco.

## Scope and Contents

The papers of artist Roy De Forest measure 11.2 linear feet and 111.86 gigabytes and date from 1916 to 2015, with the bulk of the collection dating from 1948 to 2007. The collection includes documents De Forest's painting career and involvement in the funk art movement through biographical material, correspondence, writings, professional records, printed material, photographic material, artwork, digital audio and video recordings, and artifacts.

Biographical material includes early school materials, resumes, a recording of an interview, membership materials, identification documents, certificates and awards, and family history and genealogy material. Also included in this series are obituaries, letters of condolence, and materials, including born-digital photographs and recordings, related to memorial services celebrating De Forest's life and work.

Correspondence includes letters and postcards to and from family, friends, colleagues, and arts institutions. This series also includes a few folders of greeting cards.

The writings series contains essays, lectures, exhibition texts, notes, and other materials written by Roy De Forest, including an essay, *The Vision of Paolo Uccello*, and his famous "dog lecture." Also included are writings by others, such as student dissertations on Roy De Forest, essays by Bruce Nixon, and poetry and an essay by David Zack.

Professional records include materials related to a book of memories (never published) organized by Dilexi Gallery and the Loujon Press, exhibition planning documents, an exhibition recording, materials related to the James Talcott Inc. Computer Arts program, and materials related to print documentation.

Financial records contain inventory and stock files; sales and consignment records; receipts and invoices; tax, estate, and insurance paperwork; and account books and ledgers.

Printed material includes exhibition announcements, catalogs, and posters; material related to other projects; blank cards with Roy De Forest art; clippings; press releases; newsletters and journals; books; and source material.

Photographic material includes digital and print photographs, negatives, transparencies, and slides of Roy De Forest and other individuals, as well as travel photos, images of his pets (primarily dogs), and images of his studio and works of art.

Artwork includes drawings by De Forest and others, as well as four sketchbooks.

The artifacts series contains a tote bag, t-shirt, and a puzzle, all featuring Roy De Forest artwork. Also included in the series is a patterned shirt and an "art critic" baseball cap.

## Series 2: Correspondence, circa 1948-2014

### 1 Linear foot (Boxes 2-3)

**Scope and Contents:** Correspondence includes letters and postcards to and from family, friends, colleagues, and arts institutions. There is a mixture of personal and professional correspondence. The professional correspondence often concerns exhibitions and projects, inventory and sales of artwork at galleries, invitations to events; and occasional research requests from art students, historians, and curators. The bulk of this series consists of letters to and from Roy De Forest, but correspondence dated 2007 and after are often addressed to Gloria Marchant, Roy De Forest's widow, regarding the artist's estate. Also included in this series are holiday and greeting cards.

**Arrangement:** Most of this series is arranged alphabetically, with unidentified correspondents and holiday cards grouped at the end. Correspondents with more than three letters have their own folder. Correspondents with three letters or less are in the "Miscellaneous" alphabetical folders.

**Available Formats:** The bulk of this series has been digitized, except for the last 2 folders of mostly blank greeting cards (only signed with a first name at most).

**Scope and Contents:** The writings series contains essays, lectures, exhibition texts, notes, and other materials written by Roy De Forest, including an essay, *The Vision of Paolo Uccello*, and his famous "dog lecture" titled "A Dogmatic Construct." The 1985 lecture at Skowhegan includes both a digital sound recording and transcript. Also included are draft and typescript writings by others, such as a Master's thesis on Roy De Forest, essays by Bruce Nixon, and poetry and an essay by David Zack.

**Arrangement:** Writings by Roy De Forest appear first in this series and are arranged in chronological order. Writings by others follow and are arranged alphabetically by title.

**Available Formats:** The bulk of this series has been digitized, except for blank pages and duplicates. The student thesis has only had the front cover and title page digitized.

## Series 4: Professional Records, 1968-2014

### 0.4 Linear feet (Box 3, OV 12)

**Scope and Contents:** Professional records include materials related to *The Roy De Forest Papers*, a book of memories (never published) organized by Dilexi Gallery and the Loujon Press; a professional bibliography; teaching forms; print documentation; exhibition related materials, including a recording; copies of exhibition guest books; painting descriptions; materials related to the James Talcott, Inc. Computer Art program; and lists of professional contacts.

**Arrangement:** This series is arranged alphabetically.
