Jack Delano lent his papers for microfilming 1965 and the collection was returned after filming.

Location of Originals

Originals returned to the lender, Jack Delano, after microfilming. Some of the papers were subsequently donated to the Library of Congress; some are on deposit at the Luis Munoz Marin Foundation, San Juan, Puerto Rico.

Available Formats

The collection has been microfilmed on reel NDA21. The microfilm has been digitized and is available on the Archives of American Art website.

Processing Information

The collection was microfilmed on Reel NDA21 and was returned to Jack Delano after filming. The microfilm was described in a finding aid by Jayna Josefson in 2025 and the microfilm was digitized in 2024 with funding provided by Smithsonian Collections Information System (CIS) IRM Pool Fund.

Jack Delano (1914-1997) was an illustrator and photographer in New York City, New York. Delano was a photographer for the Farm Security Administration photography project which documented urban and rural America during the Depression.

Scope and Contents:

Correspondence is between Jack Delano and Roy Stryker or Clara Dean Wakeman of the Farm Security Agency. Stryker gives Delano his field assignments as a traveling photographer; discusses FSA policy and photographic techniques; describes his own philosophy about the work; and discusses the change in budget and focus because of defense emphases, the war, subjects that should be photographed, the activities of other personnel, and personal matters. Enclosed in some of the letters are written guides to areas of the United States, including information about New England prepared by Harold Ballou for the FSA.
