Summary: The papers of New York art collector, dealer, and interior designer Hester

Diamond measure 7.0 linear feet and date from 1950 to 2022. The collection comprises biographical materials containing diaries, home improvement and collection plans, Diamond's art history notes, and other items; art collection files consisting of appraisals, expenses, early business dealings conducted by Harold Diamond, and other records; correspondence from dealers offering artworks to Diamond; professional files documenting Diamond's mineral collection, her work on VISTAS, and other activities; printed materials

consisting of clippings about Diamond, business cards, and a published book about the art collection; and photographic materials of home decor and works

of art.

The collection was donated in 2022 by The Estate of Hester Diamond via David Diamond, co-executor.

Biographical / Historical

Hester Diamond (1928-2020) was an art dealer, collector, and interior designer in New York, N.Y. Diamond was born in Bronx, N.Y. to David and Edith (née Wilbur) Klein. She received a B.A. degree in English from Hunter College in Manhattan where she frequented art museums. She married art dealer Harold Diamond in 1950. The couple shared a love of art and began collecting soon after they had married. After Harold's death in 1982, she married Ralph Kaminsky who died in 2012. In 2015, she married David S. Wilson. Along with managing the art collection, Diamond was an interior designer, a founder of VISTAS, Virtual Images of Sculpture in Time and Space, and was president of the Medici Archive Project. Diamond died in 2020 in Manhattan, N.Y.

Scope and Contents

The papers of New York art collector, dealer, and interior designer Hester Diamond measure 7.0 linear feet and date from 1950 to 2022. The collection comprises biographical materials, art collection files, dealer files, professional files, printed materials, and photographic materials.

Biographical materials consist of two diaries, an appointment book, home improvement files that include plans to accommodate Diamond's art collection, Diamond's art history class notes, Wilbur family history, and a few other items.

Diamond's files documenting her art collection consist of alphabetical binders containing information on the artworks, expense binders documenting conservation and other work done to the artworks and photography, and other files relating the collection. Included are photographs of the collection by Bruce Schwarz along with locationion information, as well as Harold Diamond's correspondence with Ben Nicholson, Willem de Kooning, Antoine Pervsher, Henry Moore, Barbara Hepworth, and other artists in the 1950s.

Dealer files consist mainly of correspondence to Diamond offering information on artworks available to purchase; however, the donor noted that Diamond did not accept most of the offers. Diamond's professional files documenting her activities outside of the art collection include material regarding her mineral collection, VISTAS publishing, Medici Archive Project, and other activities. Printed materials consist of clippings about Diamond, business cards, a published book about the Diamond art collection, and a few other items. Photographic materials are of home decor, furniture, and works of art.

Arrangement: The series is divided into 3 subseries.

- 2.3: Other Files Related to the Art Collection

Scope and Contents:

Diamond maintained detailed records on the artwork in her collection. These records have been divided into 3 subseries for alphabetical binders of collection records, collection expenses, and other files relating to the art collection. Note that binders have been disbound and material was placed into archival folders in original order.

Alphabetical binders contain appraisal forms, written descriptions of artwork, photographs, born digital material, and transactional forms. Collection expense binders consist of records relating to work done on artworks such as conservation and photography. Other files related to the collection include Harold Diamond's files of correspondence with Ben Nicholson, Henry Moore, Antoine Pervsher, Willem de Kooning, Barbara Hepworth, and other artists documenting the purchase of artworks and the early stages of the Diamond art collection. Also included are conservation agreements, framing records, and location information and photographs on digital media of the Diamond art collection by Bruce Schwarz.

Scope and Contents:

Diamond's professional files are divided into 2 subseries that include a set of alphabetical files and files for activities outside of her art collection dealings.

The alphabetical files consist of business forms, correspondence, and printed materials that relate to her art collection, as well as material on the Medici Archive Project, VISTAS, and records for artworks owned by her sons. Files for other professional activities contain records for Diamond's mineral collection, files and a scrapbook on furniture and decorative arts, VISTAS publishing, and proposals for a walker company.

Subseries 4.1: Alphabetical Files, circa 1994-2019

Scope and Contents:

The folder titles were taken from the binder labels. The binder contents are in alphabetical; however, Diamond did not alphabetize the material by a unified method. Researchers may see titles that are the first or last names of artists, titles of artworks, or a theme or subject.
