Art dealer Sara Gottlieb (1913-1981) was the founder of Gallery 72 West in New York City, New York. She was married to artist Harry Gottlieb.

Scope and Contents:

Biographical materials consist of resumes, a passport, and blank stationery. Business records include some relating to Gallery 72 West and some focusing on the sale of Harry Gottlieb's paintings, and include price lists, sales notebooks, and receipts. Scattered correspondence includes letters to Harry Gottlieb upon the death of his wife. Printed materials include clippings, exhibition announcements and catalogs, and press releases. Also found are writings and notes by Gottlieb which are autobiographical or about art. Also found are mailing lists and address notes.
