Summary:	The Jamison Thomas Gallery records measure 28.4 linear feet and 0.001 Gb and date from 1940-2000, with the bulk of the records dating from 1980-1995, reflecting the years the Gallery operated in Portland Oregon. About 1/2 of the records consist of artists' files of artists represented by the gallery and artists of interest. Also found are administrative records, client and collector files, financial and legal records, exhibition files, and publicity files. There is a 1.2 linear foot unprocessed addition to this collection donated in 2024 that includes administrative files. Materials date from circa 1990-1998.

The Jamison Thomas Gallery records were donated to the Archives of American Art in 2001 by gallery director Charles Froelick. Additional papers were donated in 2024 by former director Jane Beebe.

Processing Information

The collection was minimally processed by Kelly Nolte in 2016 with funding provided by the Smithsonian Institution's Collections Care and Preservation Fund. The Archives of American Art has implemented accelerated processing methodologies when possible in order to increase information about and access to more of our collections. Biographical / Historical

Jamison Thomas Gallery opened in Portland, Oregon in 1980 as the Folk Craft Gallery founded by William Jamison and Jeffrey Thomas. The gallery changed its focus and name in 1985 and began to specialize in contemporary photography, sculpture, and textile arts. Among the most notable artists represented by the gallery were Rick Bartow, Stuart Buehler, Dennis Cunningham, Susan Seubert, Dan May, Gus Van Sant, Ruza Erceg, Mark Bulwinkle, Jon Serl, Gregory Grenon, and Erik Stotik. Jamison Thomas Gallery closed in 1995, after William Jamison died from complications with AIDS.

Scope and Contents

The Jamison Thomas Gallery records measure 28.4 linear feet and 0.001 GB and date from 1940-2000, with the bulk of the records dating from 1980-1995, reflecting the years the Gallery operated in Portland Oregon. About 1/2 of the records consist of artists' files of artists represented by the gallery and artists of interest. Also found are administrative records, client and collector files, financial and legal records, exhibition files, and publicity files.

Among those represented in the artists' files are Robert Gilkerson, Gregory Grenon, Dan May, Jon Serl, Rick Bartow, Mark Bulwinkle, Jay Backstrand, Stuart Buehler, Mark Calderon, Baba Wague Diakite, and Gus Van Sant.

There is a 1.2 linear foot unprocessed addition to this collection donated in 2024 that includes administrative files. Materials date from circa 1990-1998.

Scope and Contents: Client and collector files document business transactions between the Jamison Thomas Gallery and various clients, collectors, and customers regarding the purchase of artwork, the transfer of artworks between locations for the purpose of consignment, or loans for exhibitions. Materials include loan and consignment agreement forms, purchase receipts and invoices, inquiries, photographs, and shipping notifications.

Subseries 2.1: Galleries, Museums, and Schools, 1980-1995

Scope and Contents: Correspondence and business agreements with other galleries, museums, and schools. Included within this subseries are guilds and artist representatives, craft collecting organizations, and stores. The majority of files consist of correspondence received by the gallery, including exhibition cards and announcements. Also included are loan and consignment agreements, sales invoices for the gallery and for other organizations, and purchase documentation.
