Biographical / Historical

The Perimeter Gallery (established 1982; closed 2015) was a gallery in Chicago, Illinois owned and operated by Frank Paluch. The gallery featured contemporary art from established mid-career artists. Originally called Perimeter Press, it expanded in 1983 and changed its name to Perimeter Gallery.

Scope and Contents

The records of the Perimeter Gallery measure 15.0 linear feet and date from 1953 to 2015. The records document the history of the gallery, located in Chicago, Illinois, through files on artists represented by or exhibited by the gallery and printed material related to exhibitions put on by the gallery.

Artist files consist of resumes, inventories and price lists, exhibition announcements and catalogs, articles, and photographic materials for artists who exhibited at the gallery. Some of the files also include records in digital format. Notable artists include: Keiko Hara, Peter Voulkos, Kathleen Holder, Dona Look, and Toshiko Takaezu. Also included are two exhibition files for the "Chaos/Control" exhibition and "Nude in Clay" exhibition.

Exhibition printed material consists of unbound binders arranged by year from 1982 to 2015. The binders contained reviews, exhibition announcements, and exhibition catalogs for exhibitions held at the gallery. Also included are binders for exhibitions held at other galleries in Chicago and New York.
