Reel NDA 1: Originals were returned to Marian Simpson after microfilming. Reel NDA 3: Originals were returned to Lewis Ferbrache after microfilming.

Available Formats

The collection was microfilmed onto 35mm microfilm reels NDA01 and NDA03. The microfilm has been digitized and is available on the Archives of American Art website.

Processing Information

The collection was microfilmed on Reels NDA01 and NDA03 and was returned to Marian Simpson and Lewis Febrache after filming. The microfilm was described in a finding aid by Jayna Josefson in 2025 and the microfilm was digitized in 2024 with funding provided by the Smithsonian Collections Information System (CIS) IRM Pool Fund.
