Summary:	The David Stuart papers and gallery records measure 1.3 linear feet and date from 1910 to 1984. The collection sheds light on Stuart's personal and professional life through scattered correspondence, photographs, and appraisal records; and his galleries' operations through scant artist files, exhibition files, photographs, and printed material.

## **Biographical / Historical**

David Stuart (1910-1984) was a gallery owner and owner of a jazz shop and record label in Los Angeles, California. Stuart opened Jazz Man Record Shop in Hollywood in 1939, and then in 1941 started a record label, Jazz Man Records. Stuart parted ways with both the label and the shop by 1946. In 1961, David Stuart along with his friend, Edward Primus, founded the Primus-Stuart Gallery in Los Angeles, California. In the same location two years later, Stuart founded David Stuart Galleries. The gallery specialized in showing emerging contemporary artists and pre-Columbian art and artifacts. Included in the list of artists shown at Stuart's galleries is John Altoon, Oliver Andrews, Sorel Etrog, Marvin Harden, and June Harwood.

## Scope and Contents

The David Stuart papers and gallery records measure 1.3 linear feet and date from 1910 to 1984. The collection contains Stuart's personal and professional papers as well as gallery records. Personal and professional papers include correspondence concerning Stuart's career in New Orleans jazz music; appraisal records of pre-Columbian artifacts; papers related to the Louis Armstrong Statue Fund in New Orleans; scattered family papers and personal photographs; and more. Gallery records shed light on the operations of both galleries owned by Stuart through scant artist, exhibition, collector, and gallery files; printed material such as newspapers clippings and gallery posters; and photographs of the gallery, artwork, and artists.

Scope and Contents: Found here is correspondence concerning Stuart's career in jazz music, including two letters from notable jazz drummer Monk Hazel; records from appraisals by Stuart of pre-Columbian artifacts; correspondence, resumes, printed material, and stationery from the Louis Armstrong Statue Fund; homemade christmas cards; and some family papers and personal photographs. Memorabilia consists of a stamp, membership cards for the Airline Navigators Association and Mouldy Fig Society, and a French lottery ticket. Also found here are sympathy letters sent to Stuart's wife, Jacqueline, and a guest book signed by visitors who came to Stuart's funeral service.

## Series 2: Gallery Records, 1960s-1983

#### 1.1 Linear feet (Box 1-2, OV 3)

Scope and Contents: This series includes correspondence with other galleries and museums, photographs of artwork, Gemini G. E. L. price lists, and several collector files that contain price lists, consignment records, and scant correspondence. Artist files consist of correspondence, biographical summaries, price lists, newspaper and magazine clippings, photographs, and exhibition ephemera. Exhibition files include photographs, reviews, press releases, and correspondence. Legal records pertaining to the gallery's exhibition, *Erotic Art*, are also present. Gallery posters feature artists George Ortman, Mel Ramos, Llyn Folkes, and others.
