Summary:	The papers of multi-media artist Elaine Sturtevant date from circa 1960-2014, with the bulk of material dating from the period of the artist's resurgence, 1990-2014. The collection measures 5.2 linear feet and 0.003 GB. The papers document Sturtevant's career and artistic process through correspondence with artists and curators, writings and illustrated notes, exhibition and catalog files, project files, and printed material. Sturtevant's voice and artistic mission emerge through the many items of correspondence, essays, and project notes in the collection. The collection also contains a few born-digital files of scans of exhibition photographs dating from the 1960s.

Biographical / Historical

Elaine Sturtevant (1924-2004) was a multi-media artist in New York and Paris known for her carefully inexact repetitions of others artists' works. She is sometimes called the "mother of appropriation art" for being among the first to question concepts such as originality, individual authorship, and plagiarism. Sturtevant had her first exhibition at the Bianchini gallery in New York in 1965, showing works resembling those of George Segal, Frank Stella, and Andy Warhol. While Sturtevant mainly withdrew from the art world in the 1970s, she reemerged in the mid-1980s and began exhibiting internationally. In the last decades of her career, Sturtevant worked increasingly in video and installation.

Scope and Contents

The papers of multi-media artist Elaine Sturtevant date from circa 1960-2014, with the bulk of material dating from the period of the artist's resurgence, 1990-2014. The collection measures 5.2 linear feet and 0.003 GB. The papers document Sturtevant's career and artistic process through correspondence with artists and curators, writings and illustrated notes, exhibition and catalog files, project files, and printed material. Sturtevant's voice and artistic mission emerge through the many items of correspondence, essays, and project notes in the collection. The collection also contains a few born-digital files of scans of exhibition photographs dating from the 1960s.

Personal and professional correspondence is with artists, admirers, students, writers, museums, and galleries. Sturtevant composed many letters, especially her emails, in a distinct and short staccato style that is poem-like. Within her correspondence, she articulates her method and process, and repeatedly reminds others to refer to her only as Sturtevant. Notable correspondents include artists Marcel Duchamp, John Waters, Trisha Donnelly, Paul McCarthy, and one postcard from Yvonne Rainer. There is significant overlap between professional and personal correspondence, as her relationships with gallerists and curators spanned many years and often assumed a personal tone. Drafts and mock-ups for exhibition catalogs, as well as a draft of Sturtevant's catalog raisonne are also arranged here. A few born-digital files contain scans of exhibition photographs dating from the 1960s.
