Washington discusses his early life in the South; effects of discrimination and the formation of a world view; art as the embodiment of spiritual truth; concept of the Absolute in art; role of the imagination; discovering form in material

as basis of sculpture; training and contacts in Seattle; Mark Tobey and Morris Graves; role of Mexico in his shift to sculpture; and philosophy and its realization in sculpture.
