Summary:	This collection, which dates from circa 1961-2006, contains audiorecordings from the UNESCO Collection of Traditional Music of the World, as well as related business records. Includes recordings of tradition and sacred music from Benin, Cameroon, Central African Republic, Côte d'Ivoire, Ethiopia, Madagascar, Malawi, Niger, Sudan, Argentina, Bolivia, Brazil, Chile, Cuba, Peru, Afghanistan, Australia, Cambodia, China, Korea, the Solomon Islands, India, Bali, Java, Japan, Laos, Mongolia, Uzbekistan, Pakistan, Thailand, Vanuatu, Vietnam, Algeria, Bahrain, Egypt, Iraq, Morocco, Oman, Syria, and Turkey.

Processing Information

The paper records (series 1) for this collection received minimal-level processing treatment in the winter/spring of 2012, where the original order of the papers was maintained--organized across 588 folders--and each folder was described in detail, especially key administrative documents (e.g., contracts). As of March 2016, neither series 2 (audio records) nor series 3 (job bags) have received even minimal-level processing.

Biographical Note

The UNESCO Collection of Traditional Music of the World included more than a hundred pioneering audio recordings of the world's traditional music published from 1961 to 2003 on a number of different recording labels. The series was launched in 1961 in collaboration with ethnomusicologist Alain Daniélou (1907-1994) and the International Music Council (created by UNESCO in 1949). The recordings in the Collection are mostly field recordings made in situ, in their original context. Each recording is accompanied by scholarly annotations and photographs. Together, these discs are a reflection of the immense variety of music making and of the position music holds within cultures around the globe.

Series 1: Textual records, circa 1960s-circa 2000s

The textual records files have been kept in their original order. All of the folders were originally numbered 1 through 588. As each of the original folders were rehoused into archival folders, the original number was transferred to the new folder, as well as the original file title. When an original folder was over-stuffed, then the folder was broken out with the same number and an accompanying square-bracketed letter to maintain order of the original folder. For example, in box 1, folder 44 was broken into 7 folders as follows: 44[a], 44[b], 44[c], etc.
