Summary:	William Ian Brinkworth's collection, dated from 1901 to 1991, includes an extensive number of black and white photographs, negatives, color transparencies, books, audio tapes, manuscripts, and research materials. The manuscripts include Brinkworth's book drafts, film treatments, correspondence, historical documents, legal documents, journals and magazines in which his work was published.

Biographical Note

William Ian Brinkworth (1914-2000) was born in Karagpur, India to British parents and raised in Scotland, France, Germany and England. His interest in art brought him to the Slade School of Fine Art in London where he was trained as a painter. While studying there, Brinkworth was named a Slade Scholar and awarded the Slade Summer Composition Prize.

The outbreak of World War II changed Brinkworth's career path from painter to soldier. He first served in the Infantry, later joined the Intelligence Corps and then worked with the Free French forces and First Special Air Service Regiment. Brinkworth was taken prisoner in Sardinia for two years and after his release was seconded as a liaison officer between the Foreign Office and the United Nations in 1946. Brinkworth's military service earned him the Member of the British Empire (MBE) medal and an appointment by the British Colonial Administration Service to the position of Assistant District Officer to the Resident of Warri, Nigeria in 1946. He went on to become District Officer and finally Senior District Officer of the region.

Brinkworth's professional responsibilities involved extensive travel throughout Nigeria to many peoples and regions including Warri, Abeakuta, Badagri, Benin, Ogwashiuku, Alaro, Ibaden, Asaba and Ado-Ekiti. While serving as District Officer, Brinkworth was able to incorporate his artistic training and interests with his administrative obligations, chiefly through the mediums of photography and film. Brinkworth's administrative status and extensive interaction with local peoples of Nigeria earned him the privilege of witnessing and filming cultural traditions never before or rarely seen by Westerners.

Brinkworth served as a British Officer in Nigeria until 1957 and continued to minister as an advisor to the independent Nigerian nation during its transition to self-government. He then returned to England and pursued work as a broadcaster, documentary filmmaker, photographer, lecturer and writer. In 1961 he published his first novel, *Jimmy Riddle* [London; Cassell & Company Ltd., 1961], which won the Putnam Award. He went on to publish the novel's sequel, *The Black List* [London; Cassell & Company Ltd, 1962], and several other books including his 1966 autobiography *The One-Eyed Man Is King* [London; Cassell & Company Ltd, 1966]. He often wrote under the pseudonym "Ian Brook." Brinkworth also published several articles in *The Geographical Magazine* and *The West African Review*.

After retiring, Brinkworth lived in France with his second wife, Marida, from 1981-1991 before returning once again to England. Much of the photographic, film and art objects from his time in Africa were lost in shipment shortly before his death in 2000. The museum received the remainder of the collection through a donation by Marida Brinkworth in 2008.

Scope and Contents

Brinkworth's black and white photographs, 35mm negatives and color transparencies form a major component of the collection and illustrate a vast array of subjects titled and arranged by Brinkworth. Many images focus on the Benin region of Nigeria, Olakun figures and shrines, hairstyles, bronze casting and Benin bronzes, tattooing, the Queens of the Oba, crafts and art objects, towns and marketplaces, seated dancing, personal adornment, agriculture and industry, and ceremonies and the daily life of Nigerian people. Subjects of special interest include the "Watchers of the Night" masquerade, the crowning of a chief in Abeokuta and the titling of a Yoruba chief. Also included are images of a Felesh priest (or "God of Thunder"), the Yoruba city of Jebba, a Popo women's cult, the Nupe people and a workshop in Bida, the University College at Ibadan and G.A. Akiola, the Aro of Igan Alade. Although the images were largely taken in Nigeria, there are a small number that depict domestic life of the Brinkworth family in England.

Brinkworth's manuscripts and personal documents include an extensive official diary from 1901 of Major W. R. Reeve-Tucker, the first British Traveling Commissioner in Nigeria. The series also includes some of Brinkworth's passports, personal notes, an "Enquiry into the Ogwashi-Uku Native Court," a treatment for the film *African Priestess*, essay and book drafts (many focusing on the mud figures of Benin), an issue of *Functional Photography*

magazine featuring an article by Ian Brinkworth, correspondence, and paperwork concerning the law suit filed against Brinkworth by Chief Obafemi Awolowo. Brinkworth's collection of publications contains books, pamphlets and articles from *Noir Et Blanc* and *Picture Post* featuring his photography.

Arrangement

Series 1 is arranged according to subject categories supplied by Brinkworth. Series 2 and 3 were kept in original order. Series 4 is organized according to Brinkworth's hand-written number annotations. All unnumbered transparencies were kept in the order in which they were received. Series 5 is arranged chronologically as well as according to Brinkworth's notes and number markings. Series 6 is arranged according to packet number, those unidentified are arranged miscellaneously. Series 7 is arranged according to subject and Series 8 is organized by tape number.

Scope and Contents: The photographic prints depict a wide variety of peoples, places and traditions. Some of the topics include Benin clay figures, hairstyling, the Oba's queens, Brinkworth's touring van, bronze casting and figures, tattooing, masquerades and other ceremonies, fishing, agriculture, crafts and marketplaces, dancing and musicians, personal adornment, architecture, transportation vehicles, beading and crown-making, cooking, shrines, temples and various art objects. Also descriptively documented is the constructed of a playing field at Alaro. All of the photographs were most likely taken between 1946 and 1957 during Brinkworth's tenure as District Office in Nigeria.

Arrangement: The 637 black and white photographs (11x17 or smaller), are organized according to subject categories supplied by Brinkworth written on the outside of the original folders. In many cases the photographs from one subject folder were distributed into several folders for preservation purposes. The folder numbers correspond to the subjects assigned by Brinkworth. Within the subject folders the photographs are also organized according to a numeric system provided by Brinkworth and his wife, Marida. Brinkworth recorded annotations of these photographs onto ¼ in. audio cassette tapes, which are also contained in the collection (the annotations conclude with number 372 on tape 6; it appears that tape 7 has been recorded over).

Some photographs were unnumbered by Brinkworth but were assigned accession numbers and kept in the folder arrangement (i.e. subject category) created by Brinkworth. Some have typed or hand-written captions on the reverse sides of the images. In some cases, duplicates of the same photograph were found amongst several folders. Unnumbered duplicates were placed with the corresponding numbered and annotated photographs. Oversized photographs were removed and put in a separate flat box (Box 5). Pages were inserted in the original folders of the oversized photographs to indicate that the photograph was relocated in Box 5. All of the black and white photographs can be found in Boxes 1-5.

Many photographs have corresponding negatives in the collection and these are identified with the negative number on the photographic enclosures (see Series V inventory). Titles of b/w photographs in quotation marks are the original titles written or typed by Brinkworth on the backs of photographs. Titles in brackets were adapted from Ian Brinkworth's annotations and audio cassettes and supplied by intern Allison Thomas in 2008. Brinkworth's original numbers annotated on the audiotapes are provided in parentheses after the accession number in the inventory and in parenthesis below the accession numbers on the folders containing the b/w photographs.

Series 2: Manuscripts and Personal Documents, 1901-1991

65 Documents (Boxes 6-7)

Arrangement: Series II, Brinkworth's manuscripts and personal documents, were kept in the original order in which they arrived at the National Museum of African Art. The folders correspond to Brinkworth's original folder content and arrangement.

Scope and Contents: This series contains Brinkworth's passports, typed and hand-written notes, book drafts and film treatments. The most prevalent focus of these documents is the art and people of Benin. Also in the series is a 1954 issue of the magazine *Functional Photography* for which Brinkworth wrote an article discussing the difficulties of storing, developing and preserving film in a harsh African climate [Brinkworth, Ian. "Aspect of Photography in Nigeria." *Functional Photography* 5 (1954): 4+].

The series also contains many items not authored by Brinkworth but personally relating to him. Among these is a folder of documents pertaining to the law suit filed against him by Chief Obafemi Awolowo. Investigation into the reasons for the law suit has yielded ambiguous results, but it is understood that the suit was settled peacefully in 1970. Also in the series is a folder of legal documents recording governmental and court processes of the Ogwashi-Uku Native Court in Nigeria during the 1940's, Brinkworth's passports, a journal from 1960 titled "Bamenda," correspondence to British Officials, historical chronologies, a 1961 issue of *MAN A Monthly Record of Anthropological Science*, and a Genesis written in Pidgin.

One item of particular interest is a document dated from 1901 to 1910. In his autobiography, *The One-Eyed Man Is King*, Brinkworth mentions his discovery of an original manuscript written by former British Traveling Commissioner Major W.R. Reeve-Tucker [Ian Brook, *The One-Eyed Man Is King* (London: Cassell & Company Ltd., 1966), 301-302.]. The passage cited by Brinkworth can be found on page 222 of the original Reeve-Tucker manuscript. Brinkworth located the manuscript in Ado-Ekiti. It was in his possession until it was donated to NMAfA with the rest of the collection. The manuscript contains a report on the state of affairs in the North Eastern District of the Lagos Protectorate covering the period between November 8, 1899 and December 31st, 1900. Reeve-Tucker reported on the political systems, natural resources, industries, marriage and burial customs, geographical features and secret societies in the North Eastern District known as "Ekitiland." Attached to the report is an incomplete collection of "Minute Papers" dated from June 1901 to May 1920. Major W.R. Reeve-Tucker is depicted with Captain W.G. Ambrose on one panel of a palace door (c. 1904-1910) carved by the Olowe of Ise, a Yoruba artist (d. 1938). This panel is in possession of the British Museum [catalogue number 1979.AF.I.4546] while the second accompanying panel is in the permanent collection at the National Museum of African Art [NMAfA permanent collection 88-13-1] [for reproduction of this panel see Sieber, Roy and Roslyn Adele Walker, *African Art in the Cycle of Life*. Washington D.C. and London, England: Smithsonian Institution Press, 1987: 55.].

Series 5: Black and White Negatives, circa 1946-1957

Cold Vault Shelves B5-6 and B5-7 (black and white negatives)

All of the negatives are located on shelves B5-6 and B5-7 in the cold vault. The unaccessioned empty negative sleeves and booklets were placed in four boxes for future reference.

Scope and Contents: 35mm b/w negatives: EEPA 2008-009-0801 to EEPA 2008-009-4422 Large format b/w negatives: EEPA 2008-009-4423 to EEPA 2008-009-4427

The negatives depict Benin clay figures, hairstyling, the Oba's queens, Brinkworth's touring van, bronze casting and figures, tattooing, masquerades and other ceremonies, fishing, agriculture, crafts and marketplaces, dancing and musicians, personal adornment, architecture, transportation vehicles, beading and crown-making, cooking, shrines, temples, the playing field at Alaro, various art objects, Nigerian colonial soldiers, government and court processes and European domestic life.

General: A few of the negatives are bent, torn or have suffered other damage. Many have corresponding b/w photographs and contact sheets, which were included in the collection when it was donated. A list of corresponding b/w negatives and b/w photographs is provided in the inventory (the last four digits of the 35mm b/w negative accession number is provided in brackets after the accession number of the corresponding b/w photograph).

Arrangement: Series V, the black and white negatives, contain 35mm and large format (3.5' x 2.25' and 5.5' x 3.75') black and white negatives. The negatives were originally housed in sleeves and booklets provided by Brinkworth and in many cases these sleeves included hand-written identifications. The booklets were arranged in chronological order and were numbered in that order, and the negatives were kept in the original order within the sleeves and booklets. These negatives were accessioned as "35 mm b/w negatives." The negatives that were not originally housed in booklets were grouped and accessioned according to numbers and letters written by Brinkworth on the negatives sleeves (these negatives have been labeled "35mm b/w negatives labeled by Brinkworth"). There were a small number of negatives in miscellaneous sleeves with no written identification. These were accessioned as "Miscellaneous 35mm b/w negatives." The large-format negatives are accessioned as "5.5' x 3.75' b/w negatives" and "3.5' x 2.25' b/w negatives."
