<b>Summary:</b>	A New York bookseller, Warshaw assembled this collection over nearly fifty years. The <i>Warshaw Collection of Business Americana: Historical</i> forms part of the Warshaw Collection of Business Americana, Subseries 1.1: Subject Categories. The Subject Categories subseries is divided into 470 subject categories based on those created by Mr. Warshaw. These subject categories include topical subjects, types or forms of material, people, organizations, historical events, and other categories. ## Administrative Information

### Acquisition Information

Historical is a portion of the Business Ephemera Series of the Warshaw Collection of Business Americana, Accession AC0060 purchased from Isadore Warshaw in 1967. Warshaw continued to accumulate similar material until his death, which was donated in 1971 by his widow, Augusta. For a period after acquisition, related materials from other sources (of mixed provenance) were added to the collection so there may be content produced or published after Warshaw's death in 1969. This practice has since ceased.

### Processing Information

In 2016, with funding provided by the Smithsonian Institution's Collections Care and Preservation Fund, the Archives Center at the National Museum of American History implemented the use of

minimal level processing standards to increase information about and facilitate access to more of our collections. A large portion of stored material from the original acquisition received minimal level processing, which resulted in additions to this Subject category. This effort included basic arrangement and replacement of non-archival housing for long-term stability, but staples and other fasteners have not all been removed. Revisions to the encoded finding aid were made to reflect the added content in context to the previously processed material.

This material consists mostly of information related to national and local historical societies and organizations in the United States. There is also some material on historic sites, people and events. It further contains a few loose images/illustrations, maps and visual chronologies. A small group of oversize materials relating to US charter documents is also present. The majority of the collection dates from the 1880s through the 1960s; some material dates as early as 1837.

#### Subseries 1: Organization and Society Records, 1843-1965

Scope and Contents: Historical Organization and Society Records contains material relating to and/or produced by historical societies and organizations. Several of these are national-level organizations, although there are also a significant number of state and local groups. Most organizations are located in the Northeastern United States (notably New York State) as well as the Midwest. Contents include publications and newsletters, information relating to events/conferences, membership correspondence, and certificates. Materials are arranged alphabetically by organization.

### Subseries 2: Historic Places, People and Events, circa 1884-1965

Scope and Contents:      Historic Places, People and Events begins at Box 2, Folder 11 with materials on historical sites/buildings in the Northeastern and Midwestern United States and the Virgin Islands. This material is brief and largely promotional. Most dates are unknown. Folder 12 in box two contains a small number of prose essays or excerpts with historic figures or events as their subjects. Of note are a 1962 Time-Life exhibit guide on the Birth of the Republic, and an excerpt of eye-witness Civil War reports.

Scope and Contents:      Images, Illustrations and Maps contains engravings, prints, portraits and other types of illustrations. Many are pages torn from books. Depicted are buildings, streets, people and scenes in nature.
