Summary:	A New York bookseller, Warshaw assembled this collection over nearly fifty years. The <i>Warshaw Collection of Business Americana: Petroleum</i> forms part of the Warshaw Collection of Business Americana, Subseries 1.1: Subject Categories. The Subject Categories subseries is divided into 470 subject categories based on those created by Mr. Warshaw. These subject categories include topical subjects, types or forms of material, people, organizations, historical events, and other categories. Petroleum is a portion of the Business Ephemera Series of the Warshaw Collection of Business Americana, Accession AC0060 purchased from Isadore Warshaw in 1967. Warshaw continued to accumulate similar material until his death, which was donated in 1971 by his widow, Augusta. For a period after acquisition, related materials from other sources (of mixed provenance) were added to the collection so there may be content produced or published after Warshaw's death in 1969. This practice has since ceased.

Processing Information

In 2016, with funding provided by the Smithsonian Institution's Collections Care and Preservation Fund, the Archives Center at the National Museum of American History implemented the use of minimal level processing standards to increase information about and facilitate access to more of our collections.

For this subject, minimal processing included arrangement to the folder level, based on prior processing and preservation action, with retention of the pre-existing arrangement when possible, if applicable. Otherwise, an order was imposed by the Processing Archivist. Some materials were consolidated to eliminate excess bulk but items within folders were not arranged further. The guide may or may not include a more refined lists of folder contents. Non-archival housing was replaced for long-term stability, but staples and other fasteners have not all been removed.

Scope and Contents

The subject category Petroleum relates to the manufacturing, refining, and sales of petroleum and other oil-based products including use in motors, spindles machinery, cylinders and by painters

Within these materials there exists producer and supplier overlap with other fuel, oil, and lubricant product lines such as linseed, rosin, whale, and refined vegetable oils. See also subject categories Automobile Industry, Aviation, Coal, Engines, Gas, Oils and Lubricants, plus other related topics, as applicable.

Petroleum includes business records, serial publications, guides and histories of specific companies, patents, images, realia, as well as widely-varied subject records. Business records also include import and export documentation and records of patents. Oversize material included with the series comprises of additional serial publications and business records.

Material related to specific subject areas provide overviews of several subjects pertaining to the petroleum industry. This includes the general history of the petroleum industry, chemistry and science related aspects of oil recovery and production, and literature about aspects of the petroleum trade intended for tradesmen. Materials extend to gas and electric companies, the automobile, aviation, and maritime industries, as well as addressing issues within the oil recovery trade such as procedures, storage equipment, and balancing safety and cost considerations.

No particular depth is present for any singular subtopic though Petroleum offers a breadth of general information about various aspects of the petroleum and its related industries.

Genre, 1865-1966

Contains serial publications produced and intended for the oil industry, stock shares, visual material, commemorative stamps, patents, company guides, oil machinery designs, government reports, and realia in the form of a pendant and commemorative coin.

Includes historical overviews of companies, background on public opinion of certain companies, and descriptions of land and processes used by specific companies. Standard Oil Company is significantly represented.
- Box 6, Folder 4 Designs, 1865, undated
Contains designs of products such as cross oil filters, transmission filters, thermo-syphon cooling system components, cellar tanks, drip pans, lubricator or tallow cups, and mining and petroleum engines.
- Box 6, Folder 5 Government Reports, 1882-1920
Reports to the State Board of Health of New York, the Chamber of Commerce of Pittsburgh, and the Department of the Interior Bureau of Mines. Subjects cover the methods and apparatus for testing inflammable oils, resources in West Virginia, and the effects of gasoline removal on the heating value of natural gas.

Contains images of beached whales, oil fields, oil wells, oil tank fires, caricatures, cartoons that include images of oil, houses of notable people in the industry, and a land map. Also contains lyrics and a poem.

Includes statistics of barrels of petroleum produced or recovered, and prices.

Aviation and Maritime, 1929-1942, undated

Contains material primarily about aviation and maritime subjects that are published by oil companies. Materials include the role of aviation in war, and recreational flying or boating.

- Box 9, Folder 3-4 Chemistry of Petroleum Processes, 1893-1945
Contains petroleum-based scientific research on such topics as the isogeotherm hypothesis of mineral occurrence and origin of petroleum, developments of carbon black, distillation of shale, cracked gasoline production processes, effective lubrication, the decomposition of polymerization of olefinic hydrocarbons, and the general science of oil recovery.
- Box 9, Folder 5 History of Petroleum Industry, 1865-1962
Contains historiographical information about gasoline, petroleum, coal, whale oil, vegetable oil, oil refining, trading, the development of processes, and the evolution of the general fuel industry. Contains French language material.

Contains publications intended for individuals working in the petroleum industry. This includes scholarly papers, committee reports presented to professional organizations, and standardized procedure descriptions. Topics include automobile engine design, factoring safety and cost in considering cracking equipment, converting cotton oil to gasoline, the decline of oil wells, and the depletion of tax provisions for the petroleum industry.
