<b>Summary:</b>	The Ernest S. and Eloise Carter collection includes photographic prints, negatives and slides taken between 1950 and 1976 in the American Southwest, Mexico and Bolivia. The Carters were research associates for the Museum of the American Indian, Heye Foundation between 1964 and 1975 and focused much of their research on petroglyphs and pictographs. In addition to photographic material there is also correspondence and documentation about the photographs in the collection.

## Biographical Note

Ernest Carter was born Ernest (Eryst of Eruie) Sigmund Schickler in Vienna, Austria in 1922. Following World War II, he left Europe for South America where he spent four years in the Andes on climbing expeditions. He changed his name from Schickler to Carter when he moved to the United States in 1951 and officially became an American citizen in 1957. Eloise Carter was born in Nebraska in 1928 and eventually became a dental assistant in the Bay Area, California, where she met and married Ernest around 1960. In 1964 Ernest and Eloise were made research associates of the Museum of the American Indian, Heye Foundation which began a long term relationship with the MAI. During this time the Carters traveled throughout California, Nevada and other location in the Southwest and Mexico to photograph petroglyphs and pictographs which were subsequently shipped to the Museum. They also collected objects which were donated to the MAI including baskets, pottery and kachinas among other items. Their relationship with the MAI tapered off after Frederick Dockstader left the museum in 1975. The Carters continued to travel and work with communities in the southwest and eventually settled in Mountain View, California.

## Scope and Contents

The Ernest S. and Eloise Carter collection includes photographic prints, negatives and slides taken between 1950 and 1976 in the American Southwest, Mexico and Bolivia as well as documentation and notes regarding their work. The bulk of the photographs and notes were made by the Carters from 1964 to 1976 while they were research associates for the Museum of the American Indian, Heye Foundation. The Carters spent much of their time photographing and researching petroglyph and pictograph sites in Arizona, New Mexico, California and Nevada producing black and white and color negatives, color slides, and photographic prints that were sent back to the MAI along with maps, notes, and reports as they were completed.

**Series 1: Photographs, 1950-1975**, is organized into four separate subseries. **Subseries 1.1 Mexico and Bolivia, Landscapes and People, 1950-1951**, includes photographs taken in Bolivia, circa

1950-1951 and in Mexico in 1964. Although it is unclear where or not Ernest Carter took the Bolivia photographs himself or acquired them while he was traveling there, the photographic prints include landscape views and portraits shot in around the city of Potosí, Bolivia. The photographs shot in Mexico include black and white negatives Carters took at the Monte Alban and Mitla ruins in Oaxaca, Mexico in July, 1964. **Subseries 1.2 US Southwest: Landscapes and Petroglyphs, 1964-1973**, the largest group of materials in the collection, includes the bulk of the work done by the Carters for the Museum of the American Indian, Heye Foundation. The subseries is arranged chronologically and then by location including sites in Arizona, New Mexico, California, Nevada and Utah. Both Eloise and Ernest shot photographs, though Eloise generally shot in black and white and Ernest in color. This subseries includes negatives, 5x7 and 35mm, slides, 120 and 35mm, and photographic prints of various sizes, some mounted. Images include wide shots of petroglyph, pictograph, and acorn grinding sites, close-ups of petroglyphs as well as landscape views.

The Carters were also prolific collectors of kachinas and other ethnographic objects from the Southwest. **Subseries 1.3 Object Photography: Kachinas, Pottery, Baskets and Other Objects, 1967-1975** includes photographs of the Carter kachinas, pottery and basket collections as well as several photographs of the Carters in their home alongside their collections. **Subseries 1.4: Educational Materials and Other Selected Studies, 1970-1973** includes photographs the Carters put together for use by the educational department. Mostly mounted prints and slides, these photographs generally were sent with specific descriptions and were selected to highlight the variations between the petroglyph sites. This subseries also includes "Pueblo Life and Work" a series of photographs shot by the Carters at Taos Pueblo, Ildenfonso Pueblo, Laguna Pueblo and Hopi Pueblo in 1973.

**Series 2: Correspondence and Photograph Documentation, 1964-1987**, includes correspondence and documentation about the photographs in the Carter collection. The majority of the correspondence is between Ernest Carter and Frederick Dockstader, director of the Museum of the American Indian, Heye Foundation (MAI), regarding the donation of photographs and objects from the Carters to the museum between 1964 and 1976. The correspondence also includes detailed expense records which document where the Carters were traveling when as well as when shipments of photographs and objects were being made through the years. The documentation includes detailed reports from the Carters research on petroglyphs, maps of various petroglyph sites, photograph lists with descriptions as well as drawings and notes.

## Arrangement

This collection is arranged into two series. Series 1: Photographs, 1950-1976, is organized in four subseries. Subseries 1.1: Mexico and Bolivia, Landscapes and People, 1950-1951, 1964; Subseries 1.2: US Southwest: Landscapes and Petroglyphs, 1964-1973; Subseries 1.3: Object Photography: Kachinas, Pottery, Baskets and Other Objects, 1967-1975; Subseries 1.4: Educational Materials and Other Selected Studies, 1970-1973. These subseries are then arranged chronologically. Series 2: Correspondence and Photograph Documentation is arranged alphabetically and then by document number.

This Series includes photographic prints, negatives and slides taken by Ernest and Eloise between 1950 and 1976 in Bolivia, Mexico and the American Southwest. This series is organized into four subseries: Subseries 1.1: Mexico and Bolivia, Landscapes and People, 1950-1951, 1964; Sub Series 1.2: US Southwest: Landscapes and Petroglyphs, 1964-1973; Sub Series 1.3: Object Photography: Kachinas, Pottery, Baskets, 1967-1975; Sub Series 1.4: Educational materials and Other Selected Studies, 1970-1973. The bulk of the collection is from the work the Carters did between 1964 and 1975 photographing petroglyph and pictograph sites in Arizona, New Mexico, California, Nevada, Utah and Colorado (Subseries 1.2). There is also a significant amount of object photography documenting the Carters large collection of Kachinas, pottery, baskets and other materials. The photographs in this series were sent to the Museum of the American Indian, Heye Foundation over the course of ten years, often with corresponding documentation. It has been noted where to find accompanying documents (in Series 2) which often have additional descriptions and information about what is photographed.

Some of the photographs in the Carter collection were originally item level cataloged in 1986. This included the photographic prints and 5x7 inch negatives. The slides and 35mm negatives were given catalog numbers but never cataloged. We have maintained the original numbers the items were given. "P" numbers refer to prints. "N" numbers refer to negatives. "T" numbers refer to slides.

Although it is unclear when these prints were given to the museum by the Carters, Ernest arrived in Bolivia (still under the name Schickler) to work on expeditions in the Andes in 1947. He left the region to come to the United States in 1951. The photographs include landscape views and portraits shot in around the city of Potosí, Bolivia.

Subseries 1.2 US Southwest: Landscapes and Petroglyphs, 1964-1973, the largest group of materials in the collection, includes the bulk of the work done by the Carters for the Museum of the American Indian, Heye Foundation. The subseries is arranged chronologically and then by location including sites in Arizona, New Mexico, California, Nevada and Utah. Both Eloise and Ernest shot photographs, though Eloise generally shot in black and white and Ernest in color. This subseries includes negatives, 5x7 and 35mm, slides, 120 and 35mm, and photographic prints of various sizes, some mounted. Images include wide shots of petroglyph, pictograph, and acorn grinding sites, close-ups of petroglyphs as well as landscape views.

**Arizona and New Mexico, 1964 December-1965 January, 1966 January**

This subseries includes images from Taos area reservations in New Mexico as well as photographs of petroglyphs from Painted Desert, Arizona taken between December 1964 and January of 1965. There are also photographs from Painted Desert in Petrified Forest National Park that were shot in January of 1966. These include images of "The Cliff" and "The Wash" sites. The Carters returned several times to the Painted Desert and not all the photographs were dated correctly. The photographs from Taos include images of the Carters host family with whom they stayed throughout the course of their work in New Mexico.

For descriptions of the Taos region photographs see Documents 102 and 111 (Box 2, Folder 7). Descriptions of "The Cliff" and "The Wash" petroglyphs in Painted Desert can be found in Documents 109 and 111 (Box 2, Folder 7).

### California and Nevada, 1965 April-1966 May

This subseries includes photographs taken during various different trips made by the Carters to examine and photograph petroglyphs in California and Nevada between April and July of 1965. This includes slides, negatives and photographic prints in both black and white and color. The first trip made in April of 1965 was first to four petroglyph sites about 20 miles north of Bishop, California which included Chalfant, Red Canyon, Newspaper Rock and Fish Slough. The Carters then continued on in May to Volcano, California, Death Valley and Smoke Creek Canyon. It should be noted that May of 1965 was their first use of color photography. There was an attempt to visit Titus Canyon, but it was closed to visitors. In July 1965, the Carters visited the Valley of Fire petroglyphs in Nevada. There was a break until October-November when the Carters visited Dark Canyon, California. Between April 1966 and May 1966 the Carters revisited sites from the previous year including Dark Canyon, Chalfant, Death Valley and Titus Canyon.

Descriptions of the Red Canyon (Bishop), Chalfant (Bishop), and Titus Canyon (Death Valley) petroglyphs can be found in Document 29 (Box 2, Folder 3). Notes on Volcano, California petroglyphs can be found in Documents 103, 105 (Box 2, Folder 7). Notes on Smoke Creek Canyon can be found in Documents 105, 111 (Box 2, Folder 7). ### Arizona and California, 1966 June, 1957 January

This subseries includes color slides taken by the Carters on various trips to examine and photograph petroglyphs in Arizona and California between June of 1966 and January of 1967. It appears that there are only color slides from this time period. In June 1966 the Carters visited petroglyphs 8 miles downstream of the Parrot Ferry Bridge on the Stanislaus River in Calaveras County. They traveled on to Arizona and New Mexico in July of 1966 revisiting the Painted Desert and Newspaper Rock (in Petrified Forest national Park). In November of 1966 they returned to Barstow, California to view petroglyphs in Black Canyon in the Opal Mountains. They again returned to Arizona in December of 1966 through January of 1967 to photograph more petroglyphs in Petrified Forest National Park.

## California, 1969-1970

This subseries includes slides, negatives and photographic prints taken during various trips made by the Carters to examine and photograph petroglyphs in California between October of 1969 and August of 1970. This includes slides, negatives and photographic prints in both black and white and color. Following a short break during 1967 and 1968, the Carters returned to Arizona and New Mexico in January of 1969 to visit with families in the Taos and Santo Domingo Pueblos. In May 1969 they returned to Arizona staying in Moencopi (Moenkopi) village and the Hopi Reservation. In October, the Carters resumed their petroglyph work photographing petroglyphs at the Petroglyph Canyon and Etcheron Valley sites in California. They returned to the Coso Range in California in May of 1970 recording petroglyphs in Renegade Canyon and Darwin's Wash. In August 1970 they began using 35mm film to be used for educational programs at the museum, shooting the lava beds northeast of Bishop, California, and petroglyphs at Fish Slough, Chidago, Red Rock Canyon and Chalfant sites.

## Series 2: Correspondence and Photograph Documentation, 1964-1987

### *0.8 Linear feet*

This series includes correspondence and photograph documentation regarding the collections of photographs and other materials the Carters donated to the Museum of the American Indian, Heye Foundation (MAI) between 1964-1975. The majority of the correspondence is between then director of the MAI, Frederick Dockstader and the Carters. There is a small amount of correspondence between Alexander Draper and William Stiles with the Carters after Dockstader left the museum in 1975 as well as correspondence between MAI staff and the Carters in the 1980s when the photo department was processing and cataloging the Carter photographs. The photograph documentation includes notes, drawings, maps and other information about the photographs themselves which are primarily of petroglyphs in the American Southwest and Mexico. All of the documents, correspondence included, were numbered by the MAI staff in the 1980s and most of the photo documentation includes the corresponding catalog numbers for the photographs.
