Kessler has been awarded with over 200 design-related awards and her work has been recognized by *Graphis*, *Communication Arts*, *PRINT*, and other design publications. In 2004, she received the American Institute of Graphic Arts (AIGA)/DC Fellow Award for her achievements in design excellence and leadership in the Washington, DC area.

She is the President and Creative Director of Kessler Design Group, and works with a variety of clients including corporations, museums, private institutions, government agencies and professional service organizations and provides such services as art direction and design, branding, corporate identity, web design, print management, marketing and strategy, editorial, and communications consulting.
