This accession consists of the files created by the Office of Exhibitions at the National Portrait Gallery (NPG) during the development of the exhibition, *The First Federal Congress, 1789-1791*, which was shown at NPG from March 2 to July 23, 1989.

The records include lender files and lender sheets; general correspondence and memoranda; drafts of the exhibition script and labels; copies of the exhibition proposal; press clippings and publicity; and photographs of the artwork. The files also contain information on the exhibition design and layout, the exhibition budget, and the development of the catalogue and brochure.
